## Improving mechanism for Protection from Sexual Exploitation and Abuse

## **Duration of Assignment:**

Approximately the period of 2 month (preferred start on 10 October 2023), maximum of 6 working days within this period.

## 1. BACKGROUND

Domovik was established in 2010 in Mitrovica North. Domovik is profiled as an organization that conducts activities concerning the psychosocial and physical health, social and legal protection and education of children, youth, and members of vulnerable groups, and as an organization that seeks to help people in understanding the factors that affect their life quality.

The primary objective of this TOR is to enhance the capacity of Domovik and Partner for effectively mechanism for protection from sexual exploitation and abuse.
