TERMS OF REFERENCE PRODUCTION OF A VIDEO OF THE PUBLIC FORUM ON THE RIGHTS OF THE CHILD

Duration of Assignment:

Maximum duration of the assignment is 1 month, with the preferred start on 21st November 2023.

1. BACKGROUND

NGO Domovik from Mitrovica North was established in 2010. During these years, NGO Domovik was fully operational, working on implementation of many projects. By orientation NGO Domovik is specialized as one that provides activities concerning the psychosocial and physical health, social and legal protection and education of children, youth, and members of vulnerable groups, and as an organization that seeks to help people in understanding the factors that affect their life quality.

- Development of a short video of the public forum;
- Production of the video of the public forum;
- Close cooperation with Domovik for the development of final product;
- Application of brand toolkits of Domovik and donors,

3.2 Domovik:

Domovik will have the responsibility for the overall management of contractor's engagement, and this will include the following:

- Ensuring that Domovik management staff provide all necessary support
- Supporting contractor in working in the field, scheduling, and logistics.
- Monitoring the delivery of milestones

4. KEY DELIVERABLES

- One fully produced video filmed based on scenarios, at locations and with participants specified by Domovik with the use of brand toolkits of Domovik and donors.
- Deliver final materials on a USB/Optical disk, in high-resolution, in mp4 and/or similar formats.

5. DURATION AND TIMEFRAME

The duration of the assignment should be within the timeframe of 1 month, preferable throughout the period starting from the 21^{st} November 2023.
